Both compounds and finished hose are compliant with applicable legislation:

European regulations: 1935/2004 and 2023/2006,

USA: FDA 21 CFR 177.2600 and the tube compound does not contain phthalate.

Rubber compound is used as hose tube material meets the FDA 21 CFR 177.2600 extraction specification for repeated use in contact with Fatty Foods.(Annex II)
